**ASSIGNMENT AND RELEASE OF
SECURITY INTEREST**


This Assignment and Release of Security Interest (this "Release") is dated as of April 30, 2010. Reference is hereby made to (a) that certain Trademark Security Agreement (the "Syscon Canada Agreement") dated as of September 30, 2008, by and between Syscon Justice Systems Canada Ltd., a British Columbia company ("Syscon Canada"), and Wells Fargo Foothill, LLC ("Bank"), and (b) that certain Trademark Security Agreement (the "US Grantor Agreement"; the Syscon Canada Agreement and the US Grantor Agreement shall be referred to collectively, as the "Agreements" and each individually, as an "Agreement") dated as of September 30, 2008 by and among T-Netix, Inc., a Delaware corporation ("T-Netix"), Evercom, Systems Inc., a Delaware corporation ("Evercom"), Securus Technologies, Inc., a Delaware corporation ("Securus"; Syscon Canada, T-Netix, Evercom and Securus shall be referred to collectively, as "Grantors" and each individually, as a "Grantor"), and Bank, recorded with the United States Patent and Trademark Office on October 6, 2008, at Reel/Frame Nos. 3865/0460, 3865/0478, and 3865/0488.

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank hereby notifies, acknowledges and agrees with each Grantor that (i) the security interest granted by such Grantor in the Trademark Collateral (as defined in each Agreement) including, without limitation, the security interest granted in the trademarks listed on the attached Schedule A, and the goodwill associated therewith (collectively, the "Marks"), is terminated, released and discharged, (ii) Bank hereby releases and forever discharges all of its right, title and interest of any kind or nature in the Marks granted, assigned or conveyed pursuant to the Agreements, and (iii) any right, title or interest of Bank in the Marks shall hereby cease and become void. Bank hereby retransfers and reassigns to each appropriate Grantor, without representation or warranty, all of Bank's right, title and interest in and to the Marks.

Bank hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the termination, release and discharge of the security interest contemplated hereby.

IN WITNESS WHEREOF, Bank has caused this Assignment and Release of Security Interest to be duly executed and delivered by its duly authorized representative as of the date first above written.
