

Assignor agrees to execute and deliver, at the request of the Assignee, all papers, instruments, and assignments, and to perform any other reasonable acts the Assignee may require in order to vest all Assignor's Right, title, and interest in and to the said Trademark in the Assignee and/or to provide evidence to support any of the forgoing in the event such evidence is deemed necessary by Assignee, to extent such evidence is in the possession or control of Assignor.


