SUPPLEMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Supplement to Intellectual Property Security Agreement (this "Supplement") is made as of the 16th day of April, 2010 by and between each of the undersigned grantors (each individually, a "Grantor", and, together, the "Grantors"), each with a principal office at One Innovation Way, Merrimack, New Hampshire, and BANK OF AMERICA, N.A., as Collateral Agent, a national association, with offices at 100 Federal Street, 9th Floor, Boston, MA 02110 (the "Grantee"), in consideration of the mutual covenants herein contained and benefits to be derived herefrom.

WHEREAS, certain of the Grantors executed and delivered that certain Intellectual Property Security Agreement dated as of October 4, 2005 (as amended and in effect, the "Agreement") in favor of the Grantee, pursuant to which the Grantors pledged, assigned and granted a security interest in favor of the Grantee in certain IP Collateral (as defined therein), which was recorded: (i) with respect to Trademarks (as defined therein), at the United States Patent and Trademark Office on October 18, 2005, at Reel 3208 and Frame 0224; (ii) with respect to Patents (as defined therein), at the United States Patent and Trademark Office on October 18, 2005, at Reel 016902 and Frame 0157; and, (iii) with respect to Copyrights (as defined therein), with the U.S. Copyright Office on October 20, 2005 at document #V3531 D217-219 P1-45.

WHEREAS, the Grantors have developed and/or acquired additional IP Collateral and desire to hereby confirm the pledge of, and the grant of a security interest in, such additional IP Collateral in favor of the Grantee.


NOW, THEREFORE, it is hereby agreed as follows:

1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Agreement.
2. Supplement to Exhibit A. The attached Exhibit A is hereby incorporated into and, as of the date hereof, made a part of Exhibit A to the Agreement.
3. Supplement to Exhibit B. The attached Exhibit B is hereby incorporated into and, as of the date hereof, made a part of Exhibit B to the Agreement.
4. Supplement to Exhibit C. The attached Exhibit C is hereby incorporated into and, as of the date hereof, made a part of Exhibit C to the Agreement.
5. Miscellaneous.
 - a. Except as provided herein, all terms and conditions of the Agreement remain in full force and effect. Each Grantor hereby ratifies, confirms and reaffirms all of the representations, warranties and covenants contained therein.
 - b. This Supplement covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.
