DREW ESTATE INC.
(a New York corporation)

with and into

DREW ESTATE HOLDING COMPANY LLC
(a Delaware limited liability company)

RECITALS

A. Drew Estate Inc. (the "Merging Corporation") is a New York corporation, duly organized, validly existing and in good standing under the laws of the State of New York, and is authorized to issue 200 shares of common stock, no par value per share, of which 100 shares are issued and outstanding.

B. Drew Estate Holding Company LLC (the "Surviving Company") is a Delaware limited liability company, duly organized and validly existing under the laws of the State of Delaware.

C. Section 1003 of the New York Limited Liability Company Law (the "NYLLCA") and Section 18-209 of the Delaware Limited Liability Company Act (the "DLLCA") respectively authorize the merger of a New York corporation organized under the laws of the State of New York with and into a Delaware limited liability company.

D. The Shareholders and the Board of Directors of the Merging Corporation shall adopt resolutions approving this Plan of Merger in accordance with the NYLLCA.

E. The Members of the Surviving Company shall adopt resolutions approving this Plan of Merger in accordance with DLLCA.

ARTICLE I

General
