TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of May 3, 2010 (the "Termination and Release"), is made from General Electric Capital Corporation, having a principal place of business at 201 Merritt 7, Norwalk, Connecticut 06856, as Agent for the Lenders (the "Security Agent") to BRPP, LLC, a North Carolina limited liability company having a principal place of business at One West Pack Square, Suite 1100, Asheville, North Carolina 28802 (the "Grantor"). Capitalized terms used herein without definition are used as defined in the Credit Agreement, dated as of December 17, 2003, by and among Blue Ridge Paper Products, Inc. (the "Borrower"), the other Credit Parties signatory thereto, the Lenders, and the Security Agent (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement") and the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, pursuant to the Security Agreement, dated as of December 17, 2003 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"), made by the Borrower and the Grantor in favor of the Security Agent, a security interest (the "Security Interest") was granted by the Grantor to the Security Agent in certain Trademarks;

WHEREAS, in connection with the Security Agreement, the parties entered into (i) a Trademark Security Agreement, effective as of December 17, 2003, which was recorded in the Trademark Division of the United States Patent and Trademark Office on January 8, 2004, at Reel 2892, Frame 0781 and (ii) a Trademark Security Agreement, effective as of September 12, 2008, which was recorded in the Trademark Division of the United States Patent and Trademark Office on October 9, 2008, at Reel 3869, Frame 0728; and

WHEREAS, the Security Agent now desires to terminate and release the entirety of its Security Interest in the Trademarks (as defined below).

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Security Agent hereby states as follows:

1. Trademarks. The term "Trademarks," as used herein, shall mean all of the Grantor's right, title and interest in or to all of the Trademarks, whether owned by the Grantor as of the date of the Security Agreement or acquired by the Grantor thereafter, but prior to the date hereof, including those listed on Schedule I.

2. Release of Security Interest. The Security Agent hereby unconditionally and irrevocably terminates, releases and discharges its Security Interest in the Trademarks, and all right, title or interest of the Security Agent in such Trademarks shall hereby cease and become void.

3. Further Assurances. The Security Agent shall execute and deliver to the Grantor all further releases and other documents (including without limitation Uniform Commercial Code termination statements), and take all other actions necessary or reasonably desirable for the release of the Security Interest.



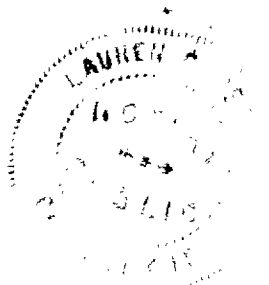
