**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of April 14, 2010, is made by Credit Suisse AG, Cayman Islands Branch, formerly known as Credit Suisse, Cayman Islands Branch ("Lender"), in favor of Accretive Solutions, Inc. ("Company") as follows:

LENDER agrees to provide Company with any information and additional authorization necessary to effect the release of Lender's security interest in the Trademark Collateral.




