IN WITNESS WHEREOF, the parties hereto have caused this Agreement to be executed as of this 20 day of April, 2010.



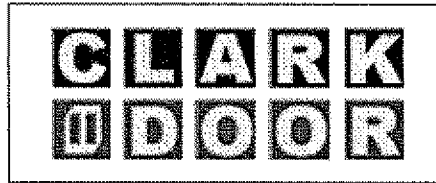
