WHEREAS, the Secured Party has agreed to terminate and release its Junior Lien Security Interest in the Trademarks identified on Schedule A attached hereto.

NOW, THEREFORE, for valuable consideration, the Secured Party hereby terminates and releases the Junior Lien Security Interest granted to the Secured Party in the following Trademarks:


1. the Trademarks identified on Schedule A attached hereto;
