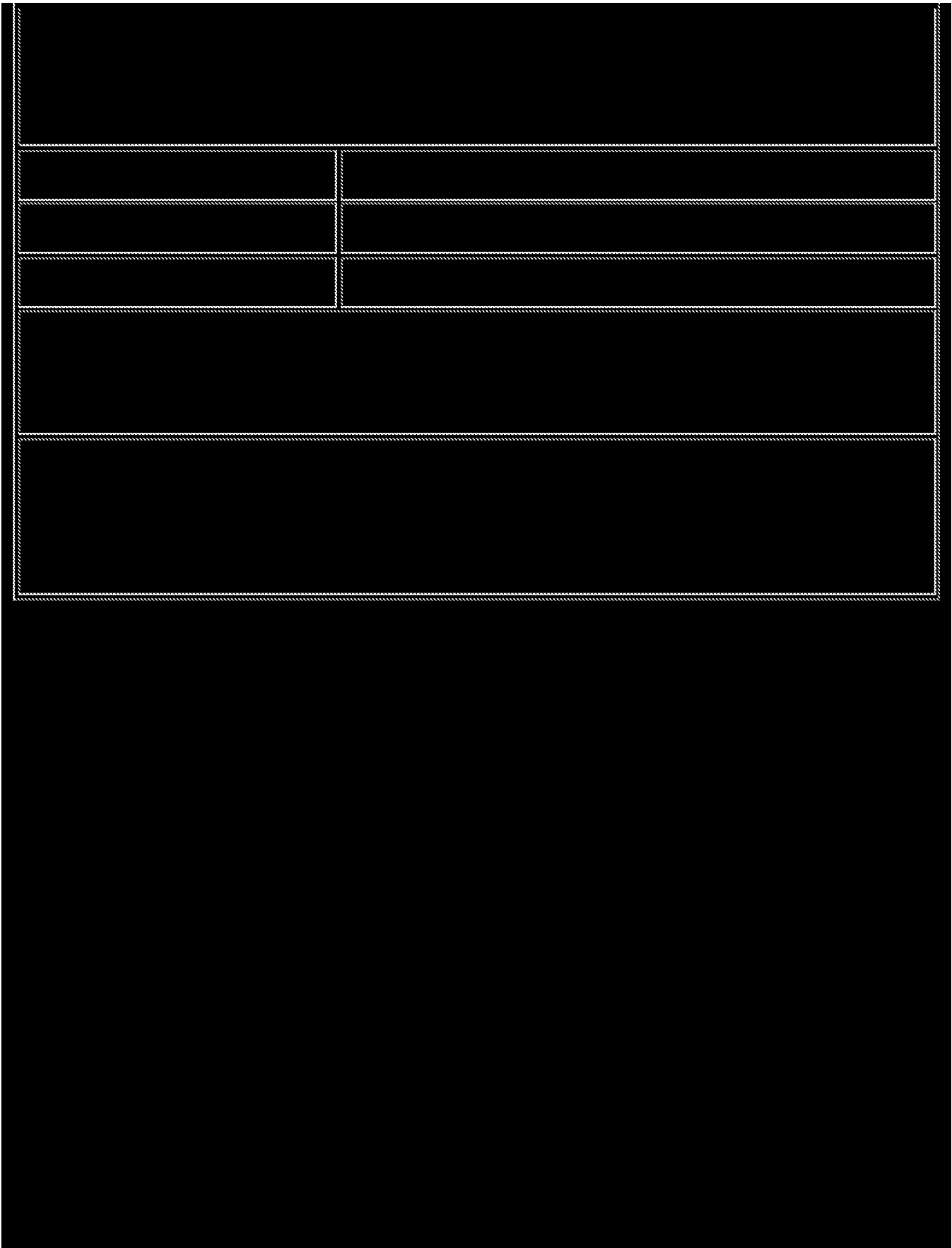

ASSIGNMENT OF TRADEMARK AGREEMENT

THIS ASSIGNMENT OF TRADEMARK AGREEMENT, agreed upon and made effective as of May 1, 2009 ("Effective Date"), is entered into by and between Bogart, Inc., a Delaware corporation (hereinafter referred to as ASSIGNOR) and Bogart, LLC, a Delaware limited liability company (hereinafter referred to as ASSIGNEE).

WHEREAS, ASSIGNOR is the owner of all rights, title and interest in and to the trademark *BOGART* as registered with the U.S. Patent and Trademark Office, Serial No. 75892483 and Reg. No. 2868210 (hereinafter referred to as TRADEMARK), including the goodwill attached thereto; and

WHEREAS, ASSIGNEE desires to acquire all rights, title and interest in and to the said TRADEMARK, including all rights, title and interest in and to its ownership and registration with the U.S. Patent and Trademark Office, together with the goodwill attached thereto;

NOW, THEREFORE, BE IT KNOWN THAT for and in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNOR hereby conveys, transfers, assigns, and delivers to the ASSIGNEE all of its rights, title, and interest in and to the TRADEMARK described herein, together with (1) the Goodwill; (2) all income, royalties and damages that become due or payable to the ASSIGNOR with respect to the Trademarks, including damages and payments for past or future infringements and misappropriations of the TRADEMARK; and (3) all rights to sue for past, present, and future infringements or misappropriations of the TRADEMARK, the same to be held and enjoyed by ASSIGNEE for its own use and for the use of its legal representatives, administrators or assigns, as fully and entirely as the same would have been held by ASSIGNOR if this assignment and transfer had not been made.

This Assignment and each of its provisions shall be binding on and shall inure to the benefit of the respective heirs, devisees, legatees, executors, administrators, trustees, successors, and assignees of the parties to this Assignment.

ASSIGNOR and ASSIGNEE have carefully reviewed this contract and agree to and accept its terms and conditions. We are executing this Assignment as of the Effective Date first written above.

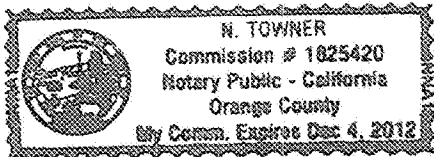

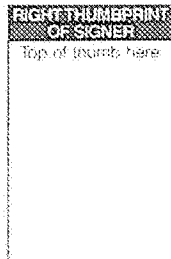

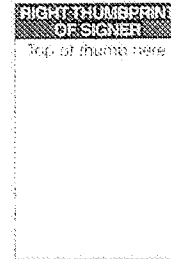
