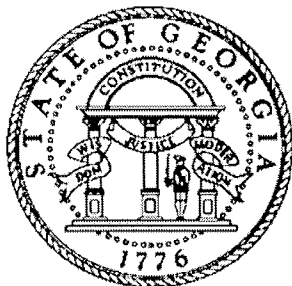


2. The Amendment contained an incorrect statement in that paragraph 2 of the Amendment inadvertently neglected to state the specific date the change in corporate name would become effective.

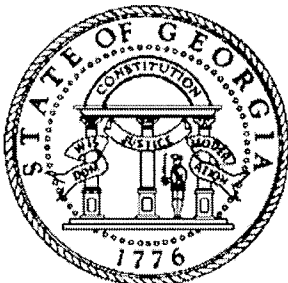
