1. She is the duly elected and acting Chief Executive Officer of Musigy USA, Inc., a Delaware corporation.

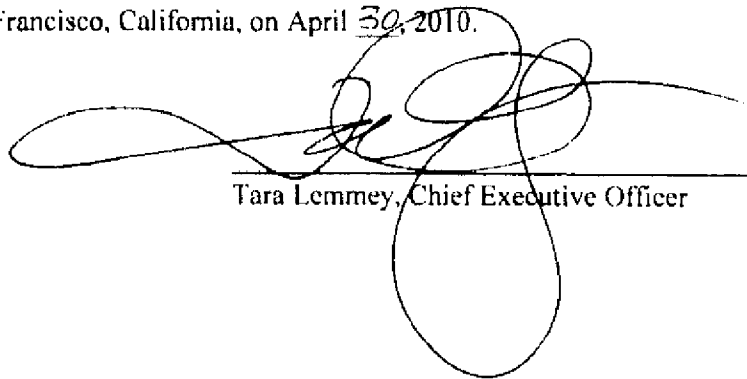
