

SUPPLEMENT NO. 3 dated as of November 3, 2006 (this "Supplement"), to the Guarantee and Collateral Agreement dated as of December 21, 2005 among Live Nation, Inc. (formerly, CCE Spinco, Inc.) ("Parent"), Live Nation Worldwide, Inc. (formerly, SFX Entertainment, Inc.) (the "US Borrower"), each subsidiary of the US Borrower listed on Schedule I thereto (each such subsidiary individually a "Subsidiary Guarantor" and collectively, the "Subsidiary Guarantors"; the Subsidiary Guarantors, Parent and the US Borrower are referred to collectively herein as the "Grantors") and JPMORGAN CHASE BANK, N.A., ("JPMCB"), as Administrative Agent (in such capacity, the "Administrative Agent").

A. Reference is made to the Credit Agreement, dated as of December 21, 2005 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Live Nation, Inc. (formerly, CCE Spinco, Inc.) ("Parent"), Live Nation Worldwide, Inc. (formerly, SFX Entertainment, Inc.) (the "US Borrower"), the Foreign Borrowers party thereto (together with the US Borrower, the "Borrowers"), the Lenders party thereto, JPMorgan Chase Bank, N.A., as Administrative Agent, JPMorgan Chase Bank, N.A., Toronto Branch, as Canadian Agent, J.P. Morgan Europe Limited, as London Agent, and Bank of America, N.A., as Syndication Agent.

B. Capitalized terms used herein and not otherwise defined herein shall have the meanings assigned to such terms in the Credit Agreement and the Domestic Collateral Agreement referred to therein.

C. The Grantors have entered into the Domestic Collateral Agreement in order to induce the Lenders to make Loans and the Issuing Bank to issue Letters of Credit. Section 7.14 of the Domestic Collateral Agreement provides that additional Subsidiaries of the Borrower may become Subsidiary Loan Parties under the Domestic Collateral Agreement by execution and delivery of an instrument in the form of this Supplement. Each of the undersigned Subsidiaries (the "New Subsidiaries") is executing this Supplement in accordance with the requirements of the Credit Agreement to become a Subsidiary Loan Party under the Domestic Collateral Agreement in order to induce the Lenders to make additional Loans and the Issuing Bank to issue additional Letters of Credit and as consideration for Loans previously made and Letters of Credit previously issued.

Accordingly, the Administrative Agent and the New Subsidiaries agree as follows:

SECTION 1. In accordance with Section 7.14 of the Domestic Collateral Agreement, each New Subsidiary by its signature below becomes a Subsidiary Loan Party (and accordingly, becomes a Guarantor and a Grantor), Grantor and Guarantor under the Domestic Collateral Agreement with the same force and effect as if originally named therein as a Subsidiary Loan Party, and each New Subsidiary hereby (a) agrees to all the terms and provisions of the Domestic Collateral Agreement applicable to it as a

The Domestic Collateral Agreement is hereby incorporated herein by reference.

SECTION 2. Each New Subsidiary represents and warrants to the Administrative Agent and the other Secured Parties that this Supplement has been duly authorized, executed and delivered by it and constitutes its legal, valid and binding obligation, enforceable against it in accordance with its terms.

SECTION 3. This Supplement may be executed in counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. This Supplement shall become effective when the Administrative Agent shall have received a counterpart of this Supplement that bears the signature of each New Subsidiary and the Administrative Agent has executed a counterpart hereof. Delivery of an executed signature page to this Supplement by facsimile transmission shall be as effective as delivery of a manually signed counterpart of this Supplement.

SECTION 4. Each New Subsidiary hereby represents and warrants that (a) set forth on Schedule I attached hereto is a true and correct schedule of the location of any and all Collateral of each New Subsidiary, (b) set forth on Schedule II attached hereto is a true and correct schedule of all the Pledged Securities of each New Subsidiary, (c) set forth on Schedule III attached hereto is a true and correct schedule of all Intellectual Property of each New Subsidiary and (d) set forth on Exhibit A attached hereto, is the true and correct legal name of each New Subsidiary, its jurisdiction of formation and the location of its chief executive office.

The parties hereto shall endeavor in good-faith negotiations to replace the invalid, illegal

or unenforceable provisions with valid provisions the economic effect of which comes as close as possible to that of the invalid, illegal or unenforceable provisions.

SECTION 8. All communications and notices hereunder shall be in writing and given as provided in Section 7.01 of the Domestic Collateral Agreement.

SECTION 9. The New Subsidiaries agree to reimburse the Administrative Agent for its reasonable out-of-pocket expenses in connection with this Supplement, including the reasonable fees, other charges and disbursements of counsel for the Administrative Agent.




