TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of April 30, 2010, by HSBC BUSINESS CREDIT (USA) INC. ("Lender"), in connection with the Loan and Security Agreement dated as of March 7, 2003 (as amended from time to time, the "Loan Agreement") by and between API Foils Inc., a Delaware corporation ("Borrower") and Lender. Capitalized terms used but not defined herein shall have the meanings given to such terms in the Security Agreement referenced below.

WHEREAS, Borrower and Lender entered into that certain Intellectual Property Security Agreement dated as of March 7, 2003 (the "Security Agreement"), which Security Agreement was recorded with the United States Patent and Trademark Office at Reel 002696, Frame 0263, on March 17, 2003, for the purpose of securing payment and performance of the Obligations;

WHEREAS, pursuant to the Security Agreement, Borrower granted, assigned and pledged to Lender, as collateral security for the Obligations, all of the Intellectual Property Collateral;

WHEREAS, Lender has agreed to release, and terminate its security interest in, the Intellectual Property Collateral and assign and transfer to Borrower all deeds, assignments and other instruments as may be necessary or proper to reassign and reconvey to re-vest in Borrower the entire right, title and interest to the Intellectual Property Collateral as herein provided;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Lender hereby releases and terminates the Security Agreement and assign and transfers to Borrower, without representation, warranty or recourse, all of Lender's right, title and interest in and to the Intellectual Property Collateral (including, without limitation, the trademarks set forth on Exhibit A hereto), effective as of the date set forth above.
