RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT


WHEREAS, CapitalSource Finance LLC, 4445 Willard Avenue, 12th Floor, Chevy Chase, Maryland 20815, a Delaware limited liability Corporation ("CapitalSource") and Punch Software LLC, ("Punch Software") have entered into a Revolving Credit, Term Loan and Security Agreement, ("Agreement") dated as of April 15, 2004, pursuant to which CapitalSource granted to Punch Software a security interest as defined in the Agreement;

NOW, THEREFORE, for good and valuable consideration receipt of which is hereby acknowledged, CapitalSource does hereby release, terminate, acquit, exonerate, forever discharge and, to the extent any interest was transferred, reassign to Punch Software its entire right and interest in the Intellectual Property listed on the Schedule created by the Agreement, and said Agreement, and the lien and security interest granted thereby to CapitalSource shall hereupon cease and terminate.

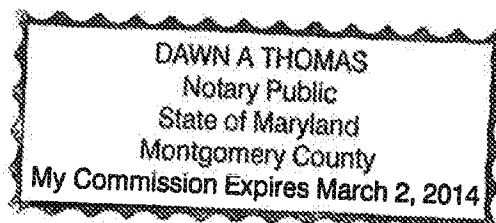
