Pursuant to the provisions of Section 251 of the General Corporation Law of the State of Delaware (the "*DGCL*"), IB Hub Sub, Inc., a Delaware corporation ("*IB Sub*"), hereby certifies the following information relating to the merger (the "*Merger*") of Orion Foundry (US), Inc., a Delaware corporation ("*Orion*"), with and into IB Sub:

FIRST: The names and states of incorporation of the constituent corporations (the "*Constituent Corporations*") in the Merger are:

FOURTH: The certificate of incorporation of IB Sub, as in effect immediately prior to the effective time of the Merger, shall be the Certificate of Incorporation of the Surviving Corporation.

FIFTH: The executed Merger Agreement is on file at the principal place of business of the Surviving Corporation whose address is 7031 Koll Center Parkway, Suite 260, Pleasanton, CA 94566.

SIXTH: A copy of the Merger Agreement will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of any Constituent Corporation.

SEVENTH: This Certificate of Merger, and the Merger provided for herein, shall become effective at upon filing with the Secretary of State of the State of Delaware.
