RELEASE OF SECURITY INTEREST IN CERTAIN INTELLECTUAL PROPERTY

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent agrees as follows:

The Administrative Agent does hereby release and convey to the Grantors, without recourse, representation or warranty of any kind, express or implied, all of the Administrative Agent's right, title and interest in and to the Grantors' right, title and interest in and to the Collateral listed on Exhibits A and B granted pursuant to the IP Security Agreements.

The Administrative Agent authorizes and requests that the Commissioner for Patents and the Commissioner for Trademarks record this Release.
