**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of this 20 day of April, 2010, from FCC, LLC, D/B/A First Capital, a Florida limited liability company having offices at 565 Fifth Avenue 19th Floor, New York, New York 10017 ("FCC"), as successor to Siemens First Capital Commercial Finance, LLC, a New York Corporation (the "Siemens"), to Skip Hop, Inc., 8th Floor 146 West 29th Street, New York, New York 10001 ("Skip Hop").

WITNESSETH:

WHEREAS, pursuant to a certain Security Interest Agreement dated April 15, 2008, made by Skip Hop in favor of Siemens (the "Security Agreement"), a security interest (the "Security Interest") was granted by Skip Hop to Siemens in certain Collateral (as defined in the Security Agreement);

WHEREAS, on May 28, 2009, Siemens transferred to FCC the Security Agreement and the Security Interest (the "Transfer");

WHEREAS, the Security Agreement and the Transfer were recorded in the Trademark Division of the United States Patent and Trademark Office on September 9, 2009, at Reel 4058 and Frames 0647 and 0667, respectively; and

WHEREAS, FCC now desires to terminate and release the entirety of its Security Interest in the Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Collateral pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, FCC hereby states as follows:

1. Definitions. The term "Collateral," as used herein, shall mean all of the FCC's right, title and interest of every kind and nature as of the date hereof in the Collateral, including the Trademark Applications and Registrations listed on Schedule A annexed hereto.

2. Release of Security Interest. FCC hereby terminates, releases and discharges its Security Interest in the Collateral, and any right, title or interest of FCC in such Collateral shall hereby cease and become void.

3. Further Assurances. FCC hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest and all of its other rights title and interest in the Collateral contemplated hereby.
