RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release") is made as of May 3, 2010 (the "Effective Date") by Wells Fargo Capital Finance, Inc., a California corporation, formerly known as Wells Fargo Foothill, Inc. which was formerly known as Foothill Capital Corporation, in its capacity as agent (in such capacity, "WFCF"), in favor of Porta Systems Corp., a Delaware corporation ("Company").

WHEREAS, pursuant to the terms and conditions of that certain Assignment, dated as of November 29, 1994 (as amended, restated, supplemented or otherwise modified from time to time, the "Trademark Security Assignment Agreement"), by and among Chemical Bank ("Bank") and WFCF, Bank assigned, transferred and conveyed to WFCF, and granted to WFCF, a security interest in all of Bank's right, title and interest in and to the Marks (as such term is defined in the Trademark Security Assignment Agreement);

WHEREAS, WFCF has consented to the release of its lien on the Marks, including, without limitation, the trademark registrations and applications listed on Schedule 1 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, WFCF hereby covenants and agrees as follows:

1. WFCF's lien on the Marks is hereby terminated and released.
2. To the extent WFCF retains any interest in the Marks, WFCF hereby assigns, transfers and conveys to Company, all of WFCF's right, title and interest, now owned or hereinafter acquired, that it may have whether by assignment or otherwise, in and to the Marks.
3. WFCF hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release at Company's sole cost and expense.


IN WITNESS WHEREOF, WFCF has caused this Release to be executed by its duly authorized representative as of the Effective Date.
