The undersigned certify that:

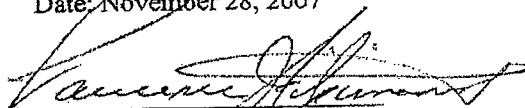
1. They are the President and the Secretary, respectively, of Line4, Inc., a California corporation.
2. The FIRST Article of the Articles of Incorporation of this corporation is amended to read in its entirety as follows:

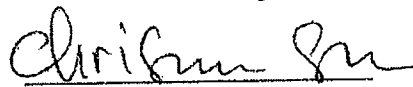
“The name of the corporation (the “Corporation”) is: LiveTouch.net, Inc.”

3. The foregoing amendment of Articles of Incorporation has been duly approved by the board of directors.
4. The foregoing amendment of Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902, California Corporations Code. The total number of outstanding shares of the corporation is 14,594,884. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50%.
