ASSIGNMENT OF TRADEMARK RIGHTS

The right, title and interest is to be held and enjoyed by Assignee and Assignee's successors and assigns as fully and exclusively as it would have been held and enjoyed by Assignor had this assignment not been made.

This Assignment shall be governed by and enforced in accordance with the laws of the State of California, without giving effect to any conflicts of law principles.

This Assignment shall be binding on, and shall inure to the benefit of, the parties hereto and their respective successors and assigns.
