THIS ASSIGNMENT ("Assignment") is made and entered into by and between Noble Fiber Technologies, Inc., a Pennsylvania corporation, formerly located and doing business at 421 South State Street, Clarks Summit, PA 18411 ("Assignor"), and Noble Fiber Technologies, LLC, a Pennsylvania limited liability company, located and doing business at 300 Palm Street, Scranton, Pennsylvania 18505 ("Assignee"). The Assignment is effective as of the date signed below.

WHEREAS, Assignor is the owner of all right, title, and interest in, to and under U.S. Trademark Registration No. 2,850,650, registered on June 8, 2004, for the mark X-STATIC for adhesives for applying floor tiles and wall coverings in International Class 001; surgical bandages, adult diapers, feminine hygiene pads, tampons, medical adhesive tape in International Class 005; protective gloves for industrial use in International Class 009; compression, elastic and orthopedic support bandages, condoms, gloves for medical use, gloves for massage, surgical gowns, medical examination gowns, braces for limbs and joints for medical use, sutures, plastic bags for transmitting medical specimens, cast liners, namely, textile linings for orthopedic casts in International Class 010; unfitted fabric covers for furniture, namely, dog beds, mattress covers, pillow cases, linen lining fabric for shoes, dish cloths in International Class 024; boxing gloves, bicycling gloves, hockey gloves, hunting gloves, golf gloves and surfing gloves, and athletic tape in International Class 028 (hereinafter referred to as the "Trademark") and has the full right to make the conveyance herein;

WHEREAS, Assignee desires, and Assignor has agreed to assign to Assignee, its entire right, title and interest in, to and under the Trademark, together with that part of the good will of the business connected with the use of and symbolized by the Trademark.

NOW, THEREFORE, for ten dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns and transfers to Assignee its entire right, title, and interest in, to and under the Trademark, and the application and registration therefor, together with that part of the good will of the business connected with the use of and symbolized by the Trademark and all rights and

causes of action to recover past, present or future damages, royalties, fees, profits or other relief, including but not limited to, equitable and injunctive relief ensuing from infringement of the Trademark.
