ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
AVX CORPORATION

AVX Corporation, a Maryland corporation, hereby certifies to the State Department of Assessments and Taxation of Maryland that:

A. The charter of the corporation is hereby amended as follows:

1. Article I, NAME, is hereby amended and restated to read in its entirety as follows:

“The name of the corporation (the “Corporation”) is AVX Aircraft Company.”

2. The first sentence of Section 5.1, Authorized Shares, is hereby amended and restated to read in its entirety as follows:

“Section 5.1 Authorized Shares. The Corporation is authorized to issue 100,000,000 shares of \$.001 par value common stock.”

3. Article VII, STOCKHOLDER ACTIONS, is hereby amended to add a second sentence to read as follows:

“The holders of common stock entitled to vote generally in the election of directors may take action or consent to any action by delivering a consent in writing or by electronic transmission of the stockholders entitled to cast not less than the minimum number of votes that would be necessary to authorize or take the action at a stockholders meeting if the corporation gives notice of the action to stockholders to the extent required by Maryland General Corporation Law as it may be amended or any successor provisions.”

B. Prior to these amendments, the corporation was authorized to issue 75,000,000 shares of common stock, par value \$.001 per share, with an aggregate par value of all the shares of common stock of \$75,000. After the amendments, the corporation has the authority to issue 100,000,000 shares of common stock, \$.001 par value per share for an aggregate par value of \$100,000. After these amendments, there is only one class of stock, and the rights and terms of the common stock did not change.

C. This amendment of the charter of the corporation has been approved unanimously by the Board of Directors and unanimously by the stockholders of the Corporation entitled to vote pursuant to the Corporation’s Articles of Incorporation, its Bylaws and the Maryland General Corporation Law.
