**BETWEEN:**

- (1) **CANTERBURY LIMITED (in receivership)** a company registered in New Zealand (Company No. 124172), whose registered office is at 147 Nelson Street, Auckland, New Zealand acting by the Receivers (the "**Assignor**");
- (2) **SHAUN NEIL ADAMS AND IAN CHARLES THURSFIELD** of **KPMG**, PO Box 1584, Shortland Street, Auckland 1140, New Zealand (the "**Receivers**"); and
- (3) **HALLCO 1698 LIMITED**, a company registered in England and Wales (Company No. 6930025) whose registered office is at 3 Hardman Square, Spinningfields, Manchester M3 (the "**Assignee**").

**RECITAL**

Pursuant to the Sale Agreement, the Assignor has agreed to purchase and the Assignor (acting by the Receivers) have agreed to procure the sale to the purchaser of whatever right, title and interest the Assignor may have in and to the Business Rights.

**1 Definitions and Interpretation**

- 1.1 In this Deed of Assignment, including the Recitals above, the following expressions shall have the following meanings:

**"CL Business Rights"**

the CL Intellectual Property and any trade or business names, internet domain names (including but not limited to the CL Business Name) email addresses, service marks, utility models, topography rights, inventions, trade secrets, know-how, get up or other rights in respect of any other intellectual property (whether capable of registration or not) and wherever existing in the world (including all renewals, extensions and revivals and all rights to apply for any of the foregoing) owned by CL as at the Transfer Date and any contracts relating to the existence of the same but excluding the CL Trade Marks;

**"CL Intellectual Property"**

such trade marks (other than the CL Trade Marks) patents, design rights, registered designs, copyright, database rights (wherever existing in the world and whether registered or not and including all renewals, extensions and revivals) and all rights to apply for any for the foregoing as may be owned by CL as at the Transfer Date but in each case subject to all licences and other rights of and obligations to third parties to which CL may be subject in relation to the same;

**"CL Trade Marks"**

those trade marks set out in schedule 1;

**"Sale Agreement"**

the sale and purchase agreement of even date entered into, inter alia, between the parties to this Deed of Assignment.

**2 Assignment**

In consideration of the payment under the Sale Agreement of the sum due in respect of this Assignment by the Assignee to the Assignor (the receipt of which is hereby acknowledged) the Assignor hereby assigns to the Assignee whatever

right title and interest it may have in and to the CL Business Rights, including (without limitation):

- 2.1 all rights of action arising or accrued in relation to any of the CL Business Rights, including (but not limited to):
  - 2.1.1 all statutory and common law rights; and
  - 2.1.2 the right to seek and recover damages or any other remedies in respect of any infringement of any of the CL Business Rights prior to the date of this Deed of Assignment;
- 2.2 the right to apply for, prosecute and obtain registered trade marks, registered designs, patents or similar protection in the name of the Assignee throughout the world in respect of the names, marks and other intellectual property comprised in the CL Business Rights, including the right to claim priority from any registered intellectual property forming part of the Business Rights; and
- 2.3 all goodwill attaching to or associated with any of the CL Trade Marks.

### 3 **Further Assurance**

The Assignor and the Receivers (for at least a period of 3 months following the date of this Deed of Assignment) shall, at the request and expense of the Assignee, do or procure the doing of all such further acts and execute or procure the execution of all such documents (including any document required by any relevant trade mark registry) as may from time to time be reasonably required by the Assignee to give full effect to the terms of this Deed of Assignment.

### 4 **Exclusion of Personal Liability**

The Receivers are party to this Assignment only for the purpose of receiving the benefit of this declaration and any other covenants, conditions or provisions in their favour contained in this Agreement and neither the Receivers nor their partners, firm, employees or agents shall incur any personal liability (nor any liability ranking as an expense of the insolvency of the Assignor) howsoever arising under or in connection with this Assignment or the transaction hereby agreed or under any deed or other document or agreement entered into pursuant to or in connection with this Assignment.

### 5 **Exclusion of Representations and Warranties**

The Assignee admits that the Assignee has inspected and made all investigations it wishes concerning the CL Business Rights and that the Assignee enters into this Assignment solely as a result of that inspection and investigation and on the basis of the terms of this Assignment and not in reliance upon representations or warranties whether written or oral express or implied made by or on behalf of the Assignor or the Receivers or their employees or any agents or representatives thereof or any of them.

### 6 **Counterparts**

This Agreement may be executed in any number of counterparts and by the parties on separate counterparts, all of which taken together constitute one and the same instrument.

7      **Governing Law**

This Deed of Assignment shall be governed by and construed in accordance with English law and the parties irrevocably submit to the exclusive jurisdiction of the English courts.
