**INTELLECTUAL PROPERTY ASSIGNMENT**

This INTELLECTUAL PROPERTY ASSIGNMENT (this “IP Assignment”), dated as of November 17, 2009, is by the estates of Knight Industries I LLC, a Delaware limited liability company (“Knight Industries”), and Knight-Celotex, LLC, an Illinois limited liability company (“Knight-Celotex” and together with Knight Industries, the “Sellers” and individually, each a “Seller”), by and through Barry A. Chatz, not individually, but solely in his representative capacity as Chapter 7 Trustee of the estates of the Debtors. Capitalized terms used but not otherwise defined in this IP Assignment shall have the meaning ascribed to such terms in the Asset Purchase Agreement (as defined herein).

**RECITALS**

WHEREAS, the Sellers and Blue Ridge Fiberboard, Inc., a Delaware corporation formerly known as MFC Acquisition, Inc., a Delaware corporation (the “Purchaser”) entered into an Asset Purchase Agreement, dated as of September 14, 2009 (the “Asset Purchase Agreement”); and

WHEREAS, pursuant to the terms and conditions of the Asset Purchase Agreement, the Sellers are to cause the assignment and delivery to the Purchaser, and the Purchaser is to take assignment and delivery of certain Intellectual Property as contemplated in the Asset Purchase Agreement.

**ASSIGNMENT**

NOW, THEREFORE, for good and valuable consideration of the premises and mutual covenants and agreements set forth herein, the receipt and sufficiency of which is hereby acknowledged, the Sellers do hereby assign unto the Purchaser, all right, title and interest it may have in and to the said Intellectual Property set forth on the attached Schedule 1.

The Sellers agree to cooperate as commercially reasonable (and at the Purchaser’s expense) with the Purchaser to enable the Purchaser to take right, title and interest in the said Intellectual Property set forth on the attached Schedule 1. Such cooperation shall include the execution of documents reasonably necessary to perfect the Purchaser’s right, title and interest in the Intellectual Property set forth on the attached Schedule 1.
