ASSIGNMENT OF TRADEMARK

This Assignment of Trademark is made as of June 1, 2009, by AccessQuery, Inc., a California Corporation ("Assignor") and XPLIVE, INC., a California Corporation ("Assignee").

1. RECITALS. Assignor is the owner of the trademark "XPLIVE" registered with the United States Patent and Trademark Office on November 20, 2007 under Registration Number 3,340,026 (hereafter "Trademark"). The Trademark identifies services described as "Providing on-line non-downloadable software for computer software development" in International Class 042. Assignor's business involves the provision of software for software development. The board of directors of Assignor has unanimously agreed to dissolve the corporation AccessQuery, Inc. no later than December 31, 2009 and to transfer all assets relating to XPLIVE software to Assignee. Assignor therefore desires to transfer Trademark to Assignee and Assignee desires to acquire the same.

2. ASSIGNMENT. Assignor hereby assigns to Assignee, its successors, assigns, and legal representatives its right, title and interest in and to the Trademark and the goodwill of the business represented thereby, as well as the right to recover any past infringements thereof, regardless of whether such infringements occurred before or after the date of this assignment. This grant further includes any rights of use.

3. CONSIDERATION. Adequate consideration for the Assignment set forth in Paragraph 2 above is hereby acknowledged as received.

4. FURTHER ASSURANCES. Assignor further agrees to execute all documents as may be required to give effect to the terms of this Agreement and to cooperate with Assignee, its successors, assigns and legal representatives, in obtaining and presenting evidence in connection therewith or in policing or enforcing of the right to transfer hereby.


