RELEASE OF TRADEMARK COLLATERAL

(i-DEAL LLC)

THIS RELEASE OF TRADEMARK COLLATERAL (this "Release") is made as of May 20, 2010, by WELLS FARGO BANK, NATIONAL ASSOCIATION, as administrative agent (in such capacity as the "Administrative Agent"), the secured party under the Security Agreement referred to below.

WITNESSETH:

WHEREAS, i-DEAL LLC ("Grantor"), and certain other entities executed that certain Security Agreement (Intellectual Property), dated as of December 14, 2006 (the "Security Agreement"), pursuant to which Grantor granted a security interest to the Administrative Agent in certain trademarks and other intellectual property of Grantor; and

WHEREAS, one or more Grant of Security Interest – Trademarks executed in connection with said Security Agreement was recorded with the United States Patent and Trademark Office at Reel 003474, Frame 0364 on February 2, 2007 and at Reel 003783, Frame 0984 on May 27, 2008; and

WHEREAS, the Administrative Agent has agreed to release all its liens on the trademarks and trademark applications of Grantor identified on Exhibit A attached hereto and made a part hereof (the "Released Collateral"), and to reconvey any and all rights in the Released Collateral to Grantor

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, the Administrative Agent hereby releases all its rights in and to the Released Collateral, reconveys to the persons legally entitled thereto all of the Administrative Agent's right, title and interest in and to the Released Collateral, all without warranty or representation of any kind.
