TRADEMARK AND SERVICE MARK ASSIGNMENT

THIS TRADEMARK AND SERVICE MARK ASSIGNMENT (this "Assignment") is made this 29th day of October, 2004, by Continuum Health Management, Inc., a Delaware corporation formerly known as Continuum Health Care, Inc. BACKGROUND

Assignors hereby irrevocably assign unto Assignee their entire right, title and interest in and to the Assigned Marks and the registrations and applications therefor, together with (i) the goodwill of the businesses in connection with which the Assigned Marks are used and which are symbolized by the Assigned Marks and (ii) the right to sue for past infringement of the Assigned Marks.
2. Assignors agree to cooperate with Assignee in order to vest all Assignors' right, title and interest in and to the Assigned Marks in Assignee and to carry out the intent of this Assignment, and Assignors further agree to take such further action and to execute such further documents and instruments as may, in Assignee's reasonable judgment, be necessary in order to evidence Assignee's ownership of the Assigned Marks.
3. This Assignment shall inure to the benefit of Assignee and its successors and assigns and shall be binding upon Assignors and their successors and assigns.
4. The Assigned Marks are being assigned, sold and transferred free and clear of all liens and encumbrances.
