**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this "Release") is made as of May 24, 2010 by **NATIONAL AUSTRALIA BANK LIMITED**, as security trustee ("Security Trustee") for the Secured Parties, in favor of PaperlinX North America, Inc., a Nevada corporation ("PPXNA"). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed in the Security Agreement (as defined below).

**WITNESSETH**

**WHEREAS**, Security Trustee PPXNA, are parties to (i) a certain Security Agreement, dated as of June 30, 2009 (the "Security Agreement"), and (ii) a certain Supplement to Security Agreement dated as of June 30, 2009 (the "Trademark Security Agreement"), pursuant to which PPXNA has granted a security interest in and continuing lien on all of PPXNA's right, title, and interest in, to and under all the assets to certain trademarks as security for the Obligations, including the trademarks set forth on Schedule A hereto; and

**WHEREAS**, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on July 10, 2009 at Reel/Frame No. 004022/0432;

**WHEREAS**, PPXNA has requested that Security Trustee release its security interest in the Trademark Collateral (as such term is defined herein below) and reassign the same to PPXNA;

**NOW, THEREFORE**, for good and valuable consideration, receipt, and sufficiency of which is hereby acknowledged:

SECTION 1. Security Trustee hereby terminates and releases its security interest in and continuing lien on all of PPXNA's right, title and interest in, to, and under all of the following assets (all of which being hereinafter referred to as the "Trademark Collateral"):

(a) all (i) United States and foreign trademarks, trade names, trade dress, corporate names, company names, business names, fictitious business names, Internet domain names, service marks, certification marks, collective marks, logos, and other source or business identifiers, designs and general intangibles of a like nature owned by PPXNA, all registrations and applications for any of the foregoing including, but not limited to, the registrations and applications referred to in Schedule A hereto, (ii) extensions or renewals of any of the foregoing, (iii) goodwill of the business connected with the use of and symbolized by the foregoing, (iv) the right to sue for past, present and future infringement or dilution of any of the foregoing or for any injury to goodwill, (v) proceeds of the foregoing, including, without limitation, licenses, royalties, income, payments, claims, damages, and proceeds of suit, and (vi) rights corresponding thereto throughout the world.

SECTION 2. COUNTERPARTS. This Release may be executed in any number of counterparts and by the parties hereto on separate counterparts, each of which when so executed, shall be deemed to be an original and all of which taken together shall constitute one and the same instrument.
