**RELEASE OF
GRANT OF SECURITY INTEREST
IN TRADEMARKS**

WHEREAS, LKN Communications, Inc. formerly known as American Communications Network, Inc. NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent does hereby release and relinquish, and does hereby reassign to the Pledgor, without representation or warranty, all of the Administrative Agent's right, title and interest in and to the Trademarks, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks, and does hereby agree that the filing of the Trademark Assignment in the United States Patent and Trademark Office as aforesaid may be removed of record.
