## NUNC PRO TUNC INTELLECTUAL PROPERTY ASSIGNMENT

This *nunc pro tunc* INTELLECTUAL PROPERTY ASSIGNMENT (herein this "Assignment"), effective as of October 23, 2008, is entered into by and among TRE Financial Services Holdings, LLC, a Delaware limited liability company ("Parent"), Tax Refund Express, Inc., a Nevada corporation doing business as Orrtax Software Solutions and TRE Financial Services ("Express"), Intellitax Software Solutions, Inc., a Washington corporation ("Intellitax"), Orrtax Intangibles, LLC, a Texas limited liability company ("Orrtax," and together with Express and Intellitax, each an "Assignor," and collectively, the "Assignors"), and Universal Tax Systems, Inc., a Virginia corporation ("Assignee").

WHEREAS, this Assignment is made pursuant to the terms and conditions of that certain Acquisition Agreement, dated October 23, 2008 (as amended, modified or supplemented in accordance with its terms, the "Acquisition Agreement"), by and among Parent, TRE Financial Services, LLC, a Delaware limited liability company doing business as INTELLITAX Software Services, the Assignors and the Assignee;

WHEREAS, this Assignment corrects and replaces the Intellectual Property Assignment dated as of October 23, 2008, which inadvertently omitted reference to the transfer of goodwill appurtenant to the transferred intellectual property;

NOW, THEREFORE, in consideration of the foregoing and the mutual agreements contained in this Assignment and the Acquisition Agreement, and for other good and valuable consideration, the value, receipt and sufficiency of which are acknowledged, the Assignors and the Assignee agree as follows:

1. Capitalized terms used but not otherwise defined herein shall have the meanings set forth in the Acquisition Agreement.
2. Each of the Assignors hereby sells, transfers, assigns, conveys and delivers to the Assignee all of its right, title and interest worldwide in, to and under the intellectual property identified on the attached Schedule 1, together with any and all goodwill appurtenant thereto and together with any rights to sue and collect for any past, present or future infringement, misappropriation or unauthorized use thereof, the same to be held and enjoyed hereinafter by the Assignee for its own use and for the use of its successors and assigns (Assignors' right, title and interest in the foregoing shall be referred to as the "Assigned IP").
3. Each Assignor shall provide to the Assignee, its successors, assigns or other representatives, such prompt cooperation and assistance as may be reasonably required in connection with effectuating the purposes of this Assignment (including by executing and delivering affidavits, declarations, oaths, exhibits, assignments, powers of attorney and other documentation to perfect the Assignee's right, title and interest in, to and under the Assigned IP).
4. The provisions of Sections 9.1 through 9.10 and 9.12 of the Acquisition Agreement shall apply *mutatis mutandis* to this Assignment.

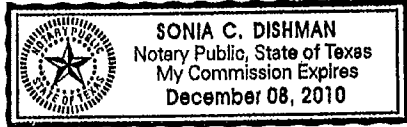

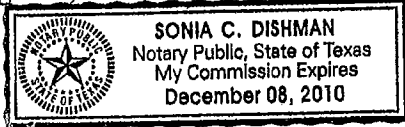

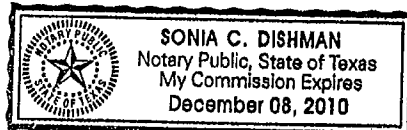
