**RELEASE OF SECURITY INTEREST IN FIRST LIEN TRADEMARK COLLATERAL**


WHEREAS, pursuant to that certain First Lien Trademark Collateral Agreement, dated August 2, 2006 (the "*Collateral Agreement*"), recorded in the United States Patent and Trademark Office on August 8, 2006 at Reel 003364, Frame 0450, Onyx Software Corporation ("*Releasee*"), a Washington corporation, granted to Harris N.A. ("*Releasor*"), a national banking association, as administrative agent for the Secured Creditors (as defined in that certain First Lien Security Agreement, dated August 2, 2006, among Releasee, certain other debtors and Releasor, as amended, modified, supplemented or restated from time to time (the "*Security Agreement*")), a lien on, and a continuing security interest in (i) each trademark, trademark registration and trademark application listed on Schedule A-1 hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration and trademark application; (ii) each trademark license listed on Schedule A-2 and all royalties and other sums due or to become due under or in respect of each such trademark license, together with the right to sue for and collect all such royalties and other sums; and (iii) all proceeds of the foregoing, including without limitation, any claim by Releasee against third parties for damages by reason of past, present or future infringement of any trademark or trademark registration listed on Schedule A-1 hereto or of any trademark license listed on Schedule A-2 or by reason of injury to the goodwill associated with any such trademark, trademark registration or trademark license, in each case together with the right to sue for and collect said damages (collectively, the "*Collateral*"); and

WHEREAS, Releasee has requested and Releasor has agreed to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its lien on and security interest in the Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the adequacy and sufficiency of which is hereby acknowledged, Releasor hereby relinquishes, releases and discharges its lien on and security interest in, and all other rights in the Collateral that Releasor has, had or could have had pursuant to the Collateral Agreement and the Security Agreement. Releasor hereby further authorizes Releasee to take any and all actions, including filing and recording this document with any and all appropriate governmental authorities, to effect and further document the release made hereby.

IN WITNESS WHEREOF, the Releasor has caused this Release of Security Interest in First Lien Trademark Collateral to be duly executed as of May 28, 2010.
