## RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is made effective as of May 10, 2010 by JPMORGAN CHASE BANK, N.A., (successor by merger to Bank One, NA) (the "Lender"), with its office at 10 South Dearborn, Chicago, Illinois 60603 to MAYFLOWER TRANSIT, LLC., a Missouri limited liability company (successor by merger to Mayflower Transit, Inc. ) (the "Grantor"), with its chief executive office and principal place of business at One Mayflower Drive, Fenton, Missouri 63026, as follows:

WHEREAS, on November 23, 1999, the Grantor, certain other entities party thereto and Bank of America, N.A. entered into a Security Agreement (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantor granted to Bank of America, N.A., among other collateral, a continuing security interest in all of the Grantor's right, title and interest, including goodwill, in, to and under the United States Trademarks listed on the attached Schedule A (the "Trademarks");

WHEREAS, the Security Agreement was recorded in the United States Patent & Trademark Office ("USPTO") on December 6, 1999 at reel/frame 2007/868 and on February 4, 2002 at reel/frame 2441/0222;

WHEREAS, on June 23, 2000, Bank of America, N.A. assigned all of its right, title and interest as collateral agent in the Security Agreement to Bank One, NA;

WHEREAS, said assignment was recorded with the USPTO on March 13, 2003 at reel/frame 2690/0001; and

WHEREAS, the Lender wishes to release its security interest in the Trademarks.

NOW THEREFORE, as the Grantor has satisfied its obligations under the Security Agreement, the Lender hereby releases, at the Grantor's sole cost and expense, all right, title and interest in and to the Trademarks, including its security interest in and lien upon the Trademarks.
