ASSIGNMENT OF TRADEMARKS AND DOMAIN NAME

This Assignment of Trademarks and Domain Name (the "Agreement") is effective as of May 13 2010, and is made by and between STROHEIM & ROMANN, INC., a Delaware corporation (the "Assignor"), and Fabricut, Inc., Oklahoma corporation (the "Assignee") (each individually a "Party;" collectively the "Parties").

WHEREAS, pursuant to the Asset Purchase Agreement, dated as of March 11, 2010, by and between the Assignor and Assignee, Assignor agreed to assign to Assignee the trademarks and domain name identified in Schedule A and Schedule B attached hereto ("Trademarks and Domain Name") and all associated goodwill in said Trademarks and Domain Name.

NOW, THEREFORE, in consideration of \$1.00 and for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby:

1. Assignment. The Assignor hereby irrevocably sells, assigns and transfers to Assignee, its successors and assigns in perpetuity the whole right, title and interest Assignor may have in and to the Trademarks and Domain Name and the use thereof, the registrations of such trademarks and any applications relating thereto, as set forth in Schedule A, and domain name, as set forth in Schedule B, together with all of the business associated with the Trademarks and Domain Name and all of the goodwill associated with or symbolized by the Trademarks and Domain Name, as fully and effectually as they would have been held by the Assignor had this Agreement not been made.

2. Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the State of New York (regardless of the laws that might otherwise govern under applicable New York conflict of laws principles).

3. Further Assurances. The Parties shall at their own cost and expense execute and deliver such further documents and instruments and shall take such other actions as may be reasonably required or appropriate to evidence or carry out the intent and purposes of this Agreement.

IN WITNESS WHEREFORE, the Assignor has caused this Agreement to be executed by its duly authorized representative.
