In accordance with Sections 180.1101 and 180.1105 of the Wisconsin Business Corporation Law, Dawes Transport, Inc., a Wisconsin corporation ("Dawes Transport"), and Roadrunner Freight Systems, Inc., a Wisconsin corporation ("Roadrunner Freight Systems"), hereby adopt the following Articles of Merger:

FIRST: The non-surviving party to the merger is Dawes Transport.
