 ROADRUNNER DAWES FREIGHT SYSTEMS, INC.**

The undersigned corporation organized and existing under and by virtue of the General Corporation Law of Delaware does hereby certify:

FIRST: The names and states of incorporation of the constituent corporations of the merger are as follows:

Roadrunner Freight Systems, Inc. (" <u>Roadrunner Freight</u> ")	Wisconsin
Roadrunner Dawes Freight Systems, Inc. (" <u>Roadrunner Dawes</u> ")	Delaware

SECOND: An Agreement and Plan of Merger (the "Merger Agreement") by and between Roadrunner Freight and Roadrunner Dawes has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations, in accordance with the provisions of Section 252(c) of the General Corporation Law of the state of Delaware and Sections 180.1101 and 180.1103 of the Wisconsin Business Corporation Law.

Pursuant to Sections 251(f) and 252 of the General Corporation Law of the state of Delaware, approval of the stockholders of Roadrunner Dawes was not required, as shares of its stock have not yet been issued.

THIRD: The name of the corporation surviving the merger is Roadrunner Dawes Freight Systems, Inc., a Delaware corporation.

FOURTH: The Certificate of Incorporation of Roadrunner Dawes as in effect immediately prior to the effective time of the merger shall be the Certificate of Incorporation of the surviving corporation.

FIFTH: An executed copy of the Merger Agreement is on file at the office of Roadrunner Dawes at 4900 S. Pennsylvania Ave. Cudahy, Wisconsin 53110.

SIXTH: A copy of the Merger Agreement will be furnished by Roadrunner Dawes, upon request and without cost, to any stockholder of any constituent corporation.


SEVENTH: The authorized capital stock of Roadrunner Freight is 1,000,000 shares of Common Stock, par value \$.001 per share.

EIGHTH: This merger shall become effective on December 30, 2005 at 9:01 a.m. EST.
