## RELEASE OF SECURITY INTEREST IN TRADEMARKS

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of June 1, 2010 (“Effective Date”) by and between **WELLS FARGO CAPITAL FINANCE, INC.**, a California corporation (formerly known as Wells Fargo Foothill, Inc.), in its capacity as Agent for the Lender Group and the Bank Product Providers (together with its successors and assigns in such capacity, “Agent”), and **VENTYX INC.** (f/k/a INDUS INTERNATIONAL, INC.), a Delaware corporation, **MOBILE DATA SOLUTIONS INC.**, a Delaware corporation, **VENTYX ASIA INC.** (f/k/a INDUS INTERNATIONAL JAPAN, INC), a Delaware corporation, **VENTYX ENERGY, LLC** (f/k/a NEW ENERGY ASSOCIATES, L.L.C.), a Delaware limited liability company, and **VENTYX ENERGY SOFTWARE, INC.** (f/k/a GLOBAL ENERGY DECISIONS, INC.), a California corporation, (collectively, jointly and severally “Grantors” and each individually “Grantor”);

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement by and between Grantors and Agent, each dated January 9, 2007, as from time to time amended, restated, supplemented or otherwise modified (the “Trademark Security Agreement”), Grantors granted to Agent a continuing security interest in and to all of Grantors’ right, title and interest in the Trademarks and Trademark Intellectual Property Licenses which it is a party thereto including those set forth therein, including without limitation those items set forth on Schedule I attached hereto (and any other trademarks, goodwill connected with the use of and symbolized by such trademarks, intellectual property licenses, modifications and renewals of the foregoing, related rights and trademark collateral set forth in any of the agreements referenced herein (collectively the “Trademark Collateral”), which security interests were variously recorded in the United States Patent and Trademark Office (“PTO”) on January 11, 2007 at Reel/Frame 3459/0820, and amendments thereto at Reel/Frame 3558/0868, Reel/Frame 3617/0906, Reel/Frame 3725/0923; Reel/Frame 4049/0087; and Reel/Frame 4181/0023;

**WHEREAS**, Grantors and Agent entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Security Agreement dated January 9, 2007 (the “Security Agreement”); and

Reference is made to that certain First Lien Credit Agreement dated January 9, 2007, as amended, restated, supplemented or otherwise modified from time to time, including all schedules thereto, (the “First Lien Credit Agreement”) among Fortezza Holdings Topco S.C.A. and Ventyx Inc. (formerly known as Indus International, Inc.), a Delaware corporation, as borrower (“Borrower”), the lenders party thereto as “Lenders” (“Lenders”) and Agent pursuant to which Grantors executed and delivered to Agent, for the benefit of the Lender Group and the Bank Product Providers, the Security Agreement;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby terminates the Trademark Security Agreement, the First Lien Credit Agreement, and the Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademark Collateral.
