WHEREAS, Assignor represents and warrants that the Trademarks are in force and effect as of the date of this Assignment and are free from any and all liens, claims, security interests or other encumbrances;

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN:

BE IT KNOWN that for and in consideration of the sum of One Dollar (\$1.00) to Assignor in hand paid by Assignee and other good and valuable consideration, including but not limited to, such consideration set forth in the Agreement, the receipt and sufficiency of which is hereby acknowledged, said Assignor does hereby sell, transfer and assign and has sold, assigned, transferred and set over as of May 14, 2010, unto the said Assignee its entire right, title and interest to said Trademarks, the same to be held and enjoyed by Assignee, for its own use and enjoyment, as fully and entirely as the same would have been enjoyed by Assignor had this Assignment and sale not been made; together with (i) all divisions, reissues and continuations thereof; (ii) all claims for damages by reason of past infringement of said Trademarks; and (iii) the right to sue for, collect the same for its own use and behalf, and for the use and behalf of its legal representatives, successors and assigns, to the full end of the term for which said Trademarks or any reissues, divisions, renewals, extensions or continuations as are granted, as fully and entirely as the same would have been held by Assignor had this Assignment and sale not been made.

Assignee is hereby authorized to make application for and/or to receive Trademarks for said listed Trademarks and pending applications (if any) in any foreign country at its election.

Assignor agrees to execute or procure any further necessary assurances of title and will execute all further instruments and to perform all acts upon the reasonable request of the Assignee and at the expense of Assignee, which may be necessary to carry this Assignment into full effect. This Assignment shall bind Assignor, its legal representatives, successors and assigns.

Assignor agrees to execute and deliver any applications, affidavits, assignments or other instruments as may be deemed necessary or desirable to secure for or vest in Assignee, its successors or assigns, all right, title and interest in and to the Trademarks.

The Commissioner of Trademarks is hereby authorized and requested to assign and/or issue any and all Trademarks of the United States to the said Assignee.
