**CERTIFICATE OF CONVERSION
OF NUBRIDGES, LLC**

1. The name of the entity electing to convert is NuBridges, LLC, a Georgia limited liability company (the "Company").

2. The Company hereby elects to become a corporation.

3. The effective date and time of the conversion is the 31st day of March, 2007, at 11:58 p.m. local time, Atlanta, Georgia.

4. The election has been approved as required by O.C.G.A. § 14-2-1109.2(a).

5. Filed with this Certificate of Conversion are Articles of Incorporation that are in the form required by O.C.G.A. § 14-2-202 and which set forth nuBridges, Inc. as the name for the corporation, which name satisfies the requirements of O.C.G.A. § 14-2-401; and the Articles of Incorporation shall be the Articles of Incorporation of the corporation formed pursuant to this election unless and until modified in accordance with O.C.G.A. § 14-2-101 et seq.

6. The manner of converting or otherwise converting the ownership interest in Old nuBridges into Shares of Corporation upon the Effective Date of the conversion is as follows:

- (a) All of the Shares in Old nuBridges shall be automatically canceled.
- (b) For each Share of Common Shares of Old nuBridges held by each Common Shareholder, such Common Shareholder shall receive one Share of Common Stock in Corporation.
- (c) For each Share of Series A Preferred Shares of Old nuBridges held by each Series A Preferred Shareholder, such Series A Preferred Shareholder shall receive one Share of Series A Preferred Stock in Corporation.
- (d) For each Share of Series B-1 Preferred Shares of Old nuBridges held by each Series B-1 Preferred Shareholder, such Series A Preferred Shareholder shall receive one Share of Series B-1 Preferred Stock in Corporation.
- (e) For each Share of Series B-2 Preferred Shares of Old nuBridges held by each Series B-2 Preferred Shareholder, such Series B-2 Preferred Shareholder shall receive one Share of Series B-2 Preferred Stock in Corporation.
- (f) For each Share of Series B-3 Preferred Shares of Old nuBridges held by each Series B-3 Preferred Shareholder, such Series B-3 Preferred Shareholder shall receive one Share of Series B-3 Preferred Stock in Corporation.
- (g) For each Share of Series B-4 Preferred Shares of Old nuBridges held by each Series B-4 Preferred Shareholder, such Series B-4 Preferred Shareholder shall receive one Share of Series B-4 Preferred Stock in Corporation.

- (h) For each option to purchase one Common Share in Old nuBridges held by an optionee, such optionee shall have the right to purchase one Share of Common Stock in the Corporation on the same terms and conditions stated in such optionee's Share Incentive Agreement executed at the time of the original option issuance (with the exercise price of one Common Share in Old nuBridges being equal to the exercise price of one Share of Common Stock of the Corporation).
