OF THE
AMENDED AND RESTATED CERTIFICATE OF INCORPORATION
OF
ICTV INC.**

ICTV Inc., a Delaware corporation, does hereby certify that the following amendments to the corporation's Amended and Restated Certificate of Incorporation (the "*Restated Certificate*") have been duly adopted in accordance with the provisions of Section 242 of the Delaware General Corporation Law, with the approval of such amendments by the corporation's stockholders having been given by written consent without a meeting in accordance with Sections 228(d) and 242 of the Delaware General Corporation Law:

A. The preamble of the Restated Certificate is amended to read in its entirety as follows:

"ActiveVideo Networks, Inc., a Delaware corporation (the "*Corporation*"), hereby certifies and provides as follows:

1. The name of the Corporation is ActiveVideo Networks, Inc. The date of filing of its original Certificate of Incorporation with the Secretary of State was November 22, 1988. The Corporation was originally incorporated under the name Inteltext Systems Inc.

2. This Amended and Restated Certificate of Incorporation restates and integrates and further amends the Certificate of Incorporation of this corporation by restating the text of the original Certificate and incorporating all subsequent amendments to read in full as follows:"

B. First Article of the Restated Certificate is amended to read in its entirety as follows:

"The name of the corporation is ActiveVideo Networks, Inc. (the "*Corporation*")."

IN WITNESS WHEREOF, the Corporation has caused this Certificate of Amendment to be signed by its duly authorized officer this 6th day of May, 2008 and the foregoing facts stated herein are true and correct.
