**RELEASE OF SECURITY INTEREST IN  
TRADEMARK COLLATERAL**

This RELEASE, dated as of May 6, 2010, is made by JPMORGAN CHASE BANK, N.A., formerly known as The Chase Manhattan Bank, a New York banking corporation, as administrative and collateral agent (the "Grantee"), pursuant to the termination of the Omnibus Pledge and Security Agreement, dated as of October 17, 2002 by and among PHILLIPS-VAN HEUSEN CORPORATION, a Delaware corporation ("PVH"), Cluett Peabody Resources Corporation, a Delaware corporation ("Cluett Peabody"), PVH Superba/Insignia Neckwear, Inc., a Delaware corporation ("PVH Superba") (collectively, the "Grantors"), the other Pledgors named therein and the Grantee (as from time to time amended, restated, supplemented or otherwise modified and in effect from time to time, the "Security Agreement"). Capitalized terms used herein but not otherwise defined herein have the meanings ascribed to them in the Security Agreement.

**WITNESSETH**

WHEREAS, under the terms of the Security Agreement, the Grantors granted, to the Grantee, a security interest in, and mortgage on, all right, title and interest in, to and under certain property and other assets of the Grantors, including Trademark Collateral (as defined below);

WHEREAS, pursuant to the Security Agreement, (i) PVH executed the Security Agreement (Trademarks) by and among PVH and the Grantee, dated October 17, 2002 and recorded with the U.S. Patent and Trademark Office on October 29, 2002 at Reel/Frame No. 2611/0402, (ii) Cluett Peabody executed the Assignment for Security by and among Cluett Peabody and the Grantee, dated January 31, 2005 and recorded with the U.S. Patent and Trademark Office on February 10, 2005 at Reel/Frame No. 3132/0276, and (iii) PVH Superba executed the Assignment for Security by and among PVH Superba and the Grantee, dated January 1, 2007 and recorded with the U.S. Patent and Trademark Office on January 4, 2007 at Reel/Frame No. 3454/0759, pursuant to which the Grantors granted to the Grantee, a security interest in, and mortgage on, all right, title and interest of Grantors in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof (the "Trademark Collateral");

WHEREAS, in connection with the Grantors' satisfaction of all of their obligations under the Security Agreement, the Security Agreement (Trademarks) and Assignments of Security have been terminated.

NOW, THEREFORE, in consideration of the foregoing, the Grantee hereby agrees as follows:

The Grantee hereby releases, transfers and assigns, without recourse, unto the Grantors, all of its security interest in, and mortgage on, all right, title and interest in, to and under the Trademark Collateral, including the trademark and service mark registrations listed on Schedule I attached hereto and incorporated herein by reference (collectively, the "Released Collateral").

The Grantee authorizes the recordation of this Release with the United States Patent and Trademark Office and any other applicable registry, the filing of Uniform Commercial Code financing statements and the filing or recording of any other document or instrument necessary to place on record the release of the Grantee's Lien upon and security interest in the Trademark Collateral by the Grantors or any persons authorized or designated by the Grantors, and any such recordation or filing shall be deemed to have been authorized by the Grantee.

The Grantee agrees to provide the Grantors with any additional authorization necessary to effect the release of its security interest in the Released Collateral.

IN WITNESS WHEREOF, the Grantee has executed this Release as of the date first set forth above.
