THIS RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS (the "*Release*") dated as of June 2, 2010, from **BANK OF AMERICA, N.A.**, a national banking association, in its capacity as agent for the Lenders (the "*Agent*") pursuant to a Trademark Security Agreement (the "*Security Agreement*") dated as of July 10, 2008 among **MOTORSPORTS AUTHENTICS, LLC**, a Delaware limited liability company ("*MA LLC*"), **MOTORSPORTS AUTHENTICS, INC.**, a Delaware corporation ("*MA Inc*"), in its own capacity and as successor by merger of **GORACING.COM, INC.**, a Delaware corporation and successor by merger of **RACING COLLECTABLES CLUB OF AMERICA, INC.**, a Delaware corporation, **ACTION SPORTS IMAGE, L.L.C.**, a Delaware limited liability company ("*Action Sports*"), **MASS RETAIL CONCEPTS, LLC**, a Delaware limited liability company ("*Mass Retail*"), and **MOTORSPORTS TRACKSIDE, LLC**, a Delaware limited liability company ("*MT LLC*") (each a "*Grantor*" and collectively, the "*Grantors*"), and the Agent.

WITNESSETH:

WHEREAS, pursuant to the Security Agreement a security interest (the "*Security Interest*") was granted by the Grantors to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined); and

WHEREAS, a notice of Security Interest in United States Trademarks was recorded in the Trademark Division of the United States Patent and Trademark Office on July 31, 2008 at Reel 003826, Frame 0905; and

WHEREAS, the Agent now desires to release its Security Interest in the Trademark Collateral set forth on Schedule 1 hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:


