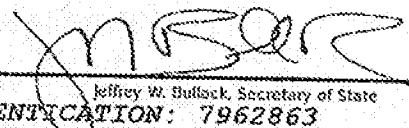

This Certificate of Formation of Alpharma, LLC is to be filed with the Delaware Secretary of State pursuant to the Delaware Limited Liability Company Act, Section 18-201.

1. The name of the limited liability company is Alpharma, LLC.
