**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "**Release**"), dated as of May 20, 2010, is made by **GENERAL ELECTRIC CAPITAL CORPORATION**, as Administrative Agent (the "**Administrative Agent**"), under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

**WHEREAS**, in connection with that certain Credit Agreement, dated as of June 9, 2006 (as amended, restated, supplemented or otherwise modified from time to time, the "**Credit Agreement**"), among iHealth Technologies, Inc. (the "**Borrower**"), the other Loan Parties signatory thereto, the Administrative Agent, and the Lenders signatory thereto from time to time, the Lenders made credit extensions to the Borrower;

**WHEREAS**, in connection with the Credit Agreement, and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "**Security Agreements**"), the Borrower and the Loan Parties granted security interests in certain intellectual property owned by the Borrower and the Loan Parties including those listed on Annex I attached hereto (collectively, the "**Intellectual Property Collateral**"); and

**WHEREAS**, the Security Agreements were recorded in the U.S. Patent and Trademark Office and the U.S. Copyright Office, as applicable, on the dates and on the reels and frames set forth on Annex I hereto;

**NOW THEREFORE**, the Administrative Agent hereby releases, without representation, recourse or warranty whatsoever, all of its security interest in the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Administrative Agent hereby reassigns any and all such right, title and interest (if any) that the Administrative Agent may have in the Intellectual Property Collateral to the Borrower and the Loan Parties, respectively.

The Administrative Agent agrees, at the Borrower's and the Loan Parties' expense, to cooperate with the Borrower and the Loan Parties and to provide the Borrower and the Loan Parties with the information and additional authorization reasonably required to effect the release of the Administrative Agent's security interest in the Intellectual Property Collateral.
