RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, Continental Commercial Products, LLC (“Debtor”) with its principal place of business at 305/333 Rock Industrial Drive, Bridgeton, MO 63044, granted a security interest in and lien upon certain Trademarks, Trademark applications and related rights to Bank of America, as Agent (successor-in-interest to Fleet Capital Corporation) (“Secured Party”) as set forth in the Trademark Security Agreement and License, dated as of April 20,2004 by Debtor in favor of Secured Party (the “Trademark Security Agreement”);

WHEREAS, Debtor has requested that Secured Party release and reassign its interest in the Trademarks and Trademark applications more fully identified in Schedule A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:

1. releases and reassigns to Debtor any and all liens, security interests, right, title and interest of Secured Party pursuant to the Trademark Security Agreement in the Trademarks and Trademark applications more fully identified in Schedule A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby, without recourse or representation or warranty, express or implied, of any kind;
2. agrees that any power of attorney or similar rights granted by Debtor to Secured Party pursuant to or in connection with the Trademark Security Agreement is terminated; and
3. authorizes and requests that the Patent and Trademark Office note and record the existence of the release hereby given.
