WHEREAS, pursuant to an Asset Purchase Agreement dated as of September 15, 2009 by and among Assignors and Assignee (the "Purchase Agreement"), Assignee is acquiring from Assignors the entire right, title and interest in, to and under the IP; and

WHEREAS Assignors desire to transfer and assign to Assignee, and Assignee desires to accept the transfer and assignment of, all of Assignors' worldwide right, title and interest in, to and under the IP;

NOW, THEREFORE,

In exchange for the good and valuable consideration set forth in the Purchase Agreement, the receipt and sufficiency of which is hereby acknowledged by Assignors, Assignors hereby sell, assign, and transfer to Assignee, its successors and assigns, the entire and exclusive right, title and interest worldwide in, to, and under the IP, together with the goodwill of the business appurtenant to and symbolized by the IP and all federal and state registrations and applications therefor, in the United States and all other countries, to be held and enjoyed by Assignee for its own use and enjoyment, and for the use and enjoyment of its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignors if this assignment and sale had not been made, and together with all claims for damages by reason of past infringement or dilution of the IP, all rights in and to any and all causes of action heretofore or hereafter accrued or accruing for infringement or dilution or threatened or alleged infringement or dilution of the IP, with the right to sue for and collect on such claims for its own use and enjoyment, and for the use and enjoyment of its successors and assigns.



Assignors agree to take all actions requested by Assignee for purposes of perfecting or otherwise evidencing Assignee's ownership of the IP and all registrations therefor.






