RELEASE OF SECURITY AGREEMENT IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of June 2, 2010 ("Effective Date") by and between **American Capital Financial Services, Inc.**, a Delaware corporation, with its principal office at 2 Bethesda Metro Center, 14th Floor, Bethesda, Maryland 20814 ("Agent"), and **Inovis USA, Inc.**, a Delaware corporation, with its principal office at 11720 Amberpark Drive, Suite 100 Alpharetta, Georgia 30004 ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement by and between Grantor and Agent dated December 5, 2005 (the "Trademark Security Agreement"), Grantor granted to Agent a continuing security interest in and to all of Grantor's right, title and interest in and to all of the Trademark Collateral (as defined in the Trademark Security Agreement), including, without limitation, the United States trademark registrations set forth on Schedule A attached hereto, together with the goodwill associated therewith (collectively, the "Trademarks");

WHEREAS, Grantor and Agent entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Note Purchase Agreement by and among Grantor, certain of Grantor's affiliates, and Agent dated December 5, 2005 (the "Security Agreement");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on January 4, 2006, at Reel 3220, Frame 0061; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to Agent.

NOW, THEREFORE, Agent hereby grants, assigns and conveys to Grantor all of its rights, title and interest in the Trademarks, and terminates, cancels and releases any and all security interests or liens it has against the Trademarks.

Agent shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
