## TRADEMARK ASSIGNMENT

Assignor also assigns to Assignee all of their right, title and interest in foreign countries based on said Multi-Mag Trademark.


Assignor also assigns to Assignee any and all claims, causes of action and damages for past infringement of the Multi-Mag Trademark.

Assignor covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this assignment and sale.


