**TERMINATION AND RELEASE OF SECURITY
INTEREST IN INTELLECTUAL PROPERTY**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Termination"), is dated as of May 26, 2010, and made by Swiss Reinsurance Company Ltd ("Grantee") to **Highway to Health, Inc.**, a Delaware corporation (the "Issuer") and Worldwide Insurance Services, Inc., a Virginia corporation ("Worldwide"; together with the Issuer, the "Grantors").

WHEREAS, pursuant to that certain Security Interest in Intellectual Property dated as of July 2, 2009, made by the Grantors in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantors to Grantee in certain collateral, including the Trademarks (as hereinafter defined) and the Patents (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on July 7, 2009, at Reel 4017 and Frame 0815, and Reel 4017 and Frame 0549;

WHEREAS, the Security Agreement was recorded in the Patent Division of the United States Patent and Trademark Office on July 7, 2009, at Reel 022917 and Frame 0597; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:


1. Definitions. The term "Trademarks," as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A attached hereto. The term "Patents," as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the patents listed on Schedule B attached hereto.

2. Release of Security Interest. Grantee hereby releases its security interest in the Trademarks and Patents and without recourse or representation reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademarks and the Patents.
