Assignor further agrees to execute any and all documents necessary or desirable to properly vest full right, title and interest in and to the Mark in the name of Assignee and its successors and assigns or which may be necessary to obtain, maintain, issue or enforce said Mark.


Assignor also hereby grants Assignee the power to insert on this Trademark Assignment any further identification that may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document
