RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this "Release") is given on May 25, 2010, by LLOYDS TSB BANK PLC, as agent and security trustee for the Finance Parties (in such capacity, the "Security Trustee") to RAYMARINE, INC., a Delaware corporation (the "Grantor").

WHEREAS, said Security Agreement was recorded in the United States Patent & Trademark Office on February 24, 2009 at reel/frame 3941/225; and


WHEREAS, Security Trustee wishes to release its security interest in the Marks.
